PUBLIC COMMENT PERIOD I (7:32 – 7:52 p.m.)

A total of 11 residents spoke at the first public comment period.

SILENCING CITIZENS

Several residents feel that muting, silencing, and censoring citizens is not appropriate.

OAKRIDGE WATER

Several residents spoke again about the horrible water conditions at Oakridge for the past 19 years. One resident feels that VRI and Delaware are awful and have failed the Oakridge resident for years, yet the Town is planning on spending more money with them (agenda item).

MEMORIAL DAY

A resident stated that he thought it was wrong that the Town gave money towards Pride flags but did not give the same amount of money towards the flag pole that is in front of the Town House.

EMERGENCY MANAGEMENT COMMITTEE

Adam Ochs, the Emergency Management Committee Chairperson read the below statement thanking all that were involved to make sure that the residents were safe during the pandemic.

BASEBALL FIELDS

A resident stated that she has written the Board about the horrible conditions at the baseball fields and would like it to be an agenda item at an upcoming Town Board meeting. She would like to have updates on what is being done and what plans they have to repair and upgrade the areas in question. She knows that Parks & Recreation is low on manpower and suggested that maybe some High Schoolers in need of community service hours could help. Another resident reiterated these comments.

<u>MEETING VENUE</u> – Discussion (8:12 – 8:21 p.m.)

Supervisor Parsons stated that the Governor has stated that Town Board meetings now must be done live. He stated that the meeting venue has been moved for the near future to the Lewisboro Library, as they can accommodate 99 people. Every meeting will also be live streamed on You Tube as well. Mr. Gonçalves stated that some residents have also asked for a hybrid meeting which would also include Zoom. There is a concern of how to manage that. And Supervisor Parsons also stated that there would be some investment that would need to be made. Residents, Ms. Rendo and Mr. Travalino, the Chair of the Cable Television Committee gave some suggestions for funds to be used, including franchise and access fees.

Supervisor Parsons stated that he plans to continue the meetings as they are this evening and that anyone can send in an email either to the Town Clerk or to the Supervisor.

<u>TOWN PROPERTY</u> – Authorization to Sell Real Property (8:22 – 8:47 p.m.)

Supervisor Parsons stated that there are two lots of basically marshland on Main Street, and the Town has been offered a price which is several times what the Assessor feels this property is worth. These lots are unbuildable according to the Wetlands Inspector. A resident asked why they were being purchased. Supervisor Parsons stated that the people purchasing these lots live close by and it was possible that these properties had lake rights. Supervisor Parsons stated that the assessed value of these lots was \$1,000 and \$2,000 which is determined by the Assessor.

A resident questioned if Supervisor Parson's Confidential Secretary was one of the purchasers and the answer was yes. Another resident questioned why these foreclosed parcels were not put up for auction, like they have done in the past and Supervisor Parsons stated this was a faster, easier and cheaper way to handle it. Residents stated that the town should be consistent with how they sell the properties.

Supervisor Parson's Confidential Secretary, who was in attendance, did address the audience.

Mr. Sklarin asked about the appraisal and Supervisor Parsons stated that it was done by the Assessor. Mr. Sklarin feels that based upon the Assessors professional opinion regarding both the appraisal and fair market value, he is fine with the sale.

Mr. Gonçalves feels that the auction should take place like how the town has handled these types of properties in the past.

Mr. Welsh feels that if the Town did put these parcels up for auction, they would not render as much money as what is being offered today.

Ms. Crimmins voted in favor.

A resident who has been the manager for Farvue Farms for 30 years stated that voices matter and if you are unhappy about something in town, then speak up. She was unhappy about what was going on at the salt dome and she continued to voice her displeasure and urged others to do the same.

MEETING ROOM LAYOUT

One resident stated that he would prefer that the Town Board be on the same level as all the residents.

CLAIMS - Authorized for Payment

POLLING OF BOARD AND ANNOUNCEMENTS

CANNABIS

Mr. Sklarin stated that with the cannabis legislation, he mentioned his position at the last meeting. His view is that the Town should opt out. And if the residents want to bring a petition to reverse that decision, then this will be democracy in action. Mr. Gonçalves also feels that the Town needs more time to understand what this law will mean so he feels that it is best to opt out at this point.

JUNETEENTH & PRIDE IN THE PARK

Mr. Sklarin, Mr. Gonçalves and Ms. Crimmins stated that they attended both the Juneteenth and Pride in the Park events held at Onatru and thanked all that took part. Ms. Crimmins stated that both events were very unifying. She also stated that approximately 300 people attended the Pride in the Park.

CHILD SEAT SAFETY

Mr. Gonçalves thanked the Lewisboro Police Department for putting together the Child Seat Safety event and Coffee with a Cop that was held at the Town Park.

WIRELESS MASTER PLAN

Mr. Gonçalves stated that he had a meeting with City Scape, who is working on the wireless master plan study. They are looking at getting more geography information from the County and then a survey will go out soon.

GRANTS ADVISORY COMMITTEE

Supervisor Parsons stated that if anyone is interested in joining the Grant's Advisory Committee to please reach out to him.

EAST OF HUDSON

Supervisor Parsons stated that he had a meeting at Lake Katonah this morning. There is a broken pipe that is letting silt enter the lake and he is hoping that the East of Hudson will pay for this repair.

TRAFFIC STUDY ON 684 & 84

The 684 & 84 corridor study has been completed after about 2 years and to complete everything, the cost would be approximately \$1 ½ billion. It would expand the lanes, improving the junction on Saw Mill and 684, junction of 684 & 84, and Route 138 in Goldens Bridge. Supervisor Parsons has reached out to Assemblymember Burdick and Congressmember Maloney, who is part of the Transportation Committee, and hopes part of the money will come as part of the infrastructure improvements.

COMPTROLLER'S REPORT

Supervisor Parsons stated that the Comptroller's report for 2020 could be found on the town's website. Parks & Recreation's total income was down by \$740,000, fines were down by \$103,000, and the Building Department raised their revenue by \$25,000. After the sale of the Golden's Bridge Community House, the unassigned fund balance went up by \$500,000. The Board is hoping that the Town's bond rating will soon be increased.

EXECUTIVE SESSION – To Discuss Legal Issues and Appointments

On motion by Supervisor Parsons, seconded by Ms. Crimmins, the Board voted 5-0 to go into executive session at 9:20 p.m. to discuss legal issues and appointments.
