Councilwoman Rendo stated that she is not anti-library, however she feels it is important for the residents to understand that the Lewisboro Library is not a municipal library and it's not owned or run by the town. It's not a library that has its own taxing district, so the money that they use to run the library does not come from collecting taxes on behalf of it as a taxing district. Instead, they are a library association and that means they receive the majority of their money to run the library from the town and that money is taken out of our taxes and given a budget line. Most of the money goes there and therefore the Town has a contract with the library, through which they pay this amount.

She stated that the library has their own board, and they determine the budget and the expenditures and the employees, and the town has no say over the runnings of the library.

Councilwoman Rendo stated that this year, the library has determined it will cost a total of \$642,167.45 to run the library and of that amount approximately \$455,000 goes towards salary and benefits of the library employees and approximately \$95,000 goes towards books, media, programs and services to the public. This year the town has budgeted a total of \$455,914 to the library.

Councilwoman Rendo stated that Councilwoman Shah is the liaison to the library, so she hopes that she can help her to better understand the cost benefit analysis for the town.

Councilman Sklarin stated that he was a trustee of the library for six years. The Lewisboro Library is an association library and does not have the ability to raise funds directly by way of

taxes to sustain the operations. He also stated that if you look at the other Westchester libraries, our town is 35 out of 35 per capita.

Councilwoman Shah stated that she was on the library board for 8 years and she knows that the Board of Trustees run a tight ship and come up with creative ways to fundraise. She also stated that several years ago, the library board attempted to have a vote to change the status of the library from an association library to a separate tax line item and it was voted down by the residents with a 2 to 1 vote.

Councilman Walsh also feels that salaries of the employees are services as well.

COMMUNICATIONS

CONSERVATION ADVISORY COUNCIL – Annual Report Submitted

She also asked how she could get a letter read into the minutes as she has sent several of them, but they have not been read. She would also like the Board to answer the questions that have been asked during the public comment portion of the meetings. She also stated that Lewisboro is a municipality, and the board needs to regulate themselves within the municipality as it is not commercial property. She also offered her knowledge and assistance as a 30-year property manager.

During polling of the board, Supervisor Gonçalves stated that they would be in touch with her regarding the progress at the salt dome. He also stated that if she would like a letter read into the minutes to email it to him and he will strive to do that.

OAKRIDGE SEPTIC

An Oakridge resident asked on 12/9/21 about a status update on septic issues on Fox Run. She stated that there has been another issue. She is again asking for updates on the septic issues; has any funding been obtained and what is the status update.

During polling of the board, Supervisor Gonçalves stated there was a problem about 3 months ago with a new and improved pump station. The recent problem was a clogged waste line. When it was unclogged, they found a lot of grease and many things that should not be flushed down toilets. A notice will be sent out with guidance as to what not to flush down the toilets.

Supervisor Gonçalves stated that they are still waiting to hear about the funding and he will be following up with his contact in the coming weeks.
