## **COMMUNICATIONS**

## <u>POOL CONCESSION BID</u> – Discuss Lease Terms (7:50 – 7:55 p.m.)

Westchester Food Service's proposal for the pool concession stand was approved by the Town Board at the March 28<sup>th</sup>, 2022, Town Board meeting. No agreement has been signed to date. Supervisor Gonçalves stated that due to rising costs, Westchester Food Service wants a modification to the agreement. They would like to amend it to a 1-year agreement from a 3-year

agreement and lower the lease payment to \$5,000 from \$8,500. After some discussion, the Board agreed to the modification and authorized the supervisor to sign the agreement.

# <u>COMMUNITY & TOWN EVENTS</u> – Juneteenth Discussion (7:55 – 8:33 p.m.)

Supervisor Gonçalves stated that Juneteenth is a national holiday, and it will be recognized as a town event that is town sponsored. This means the fees will be waived for the town park and the town will provide insurance.

Councilwoman Shah stated that a budget was presented to the Board by the Juneteenth organizers for \$5,000, however she spoke with the group and told them that due to budgetary reasons, the town could not pay that full amount. Councilwoman Shah would like to give some money to each group and to also help them with fundraising the remainder of the money.

Councilwoman Rendo is not against any of these events, but she feels that guidelines need to be in place that the Board follows. Councilwoman Shah said that the Parks & Recreation Advisory Council recommended that starting next year the town would have an open application period where groups could apply for money.

Councilman Welsh feels that these two events are very special and should be sponsored by the town and \$1,000 equates to about \$.25 per household.

Councilman Sklarin asked about if any money was dedicated to the Veteran's and the answer was no, but banners are hung for them by the maintenance department. A flagpole was also offered to be moved from the Community House to the Town House, but it proved to be cheaper for the Veteran's Committee to just order their own.

The Board continued their discussion and made an additional resolution for the Juneteenth budget.

PRIDE IN THE PARK – Discussion (7:55 – 8:33 p.m.)

The Board introduced two members of the Lewisboro LGTBQ+ Pride Taskforce, Rachel Simon and Michel Pignatiello. They went over some highlights from last year's event which included over 300 people in attendance and pride lawn signs being handed out on the front lawn of the Town House. They thanked the Board for their support.

Mr. Pignatiello went over the resolution that was passed last year – see below:

WHEREAS, the Town Board wishes to foster a spirit and atmosphere within the Lewisboro community that embraces the LGBTQIA+ community's celebration of diversity and acceptance of all gender identities; and

WHEREAS, the Town Board has determined that is vital that Lewisboro's LGBTQIA+ residents feel that their rights are equal and protected in their hometown community; and

WHEREAS, organized LGBTQIA+ PRIDE events are a proactive step the Town can take to assist in the creation and improvement of such diversity and acceptance among its residents and within the community;

NOW THEREFORE BE IT RESOLVED that The Town Board of the Town of Lewisboro hereby designates the month of June as LGBTQIA+ Pride Month; and

BE IT FURTHER RESOLVED that the Town Board hereby authorizes the formation of a Task Force for the purposes of coordinating community events in Lewisboro in honor, recognition and celebration of the LGBTQIA+ Community, as well as advising the Town Board as to the scheduling and conducting of such events; and

BE IT FURTHER RESOLVED that the Town Board hereby authorizes the expenditure of the sum of up to \$1,000 for all purposes in furtherance of the LGBTQIA Task Force declaration and

BE IT FURTHER RESOLVED that Councilwoman Jane Crimmins is hereby designated as liaison to the referenced Task Force.

The Task Force is planning 2 events with the main event being Pride in the Park on June 26<sup>th</sup> at Onatru Park and Pride Dance on June 11 at Onatru. They are looking for a liaison to be named, \$1,000 for supplies and tables, the town hang the banners at the shopping centers and the town fly the pride flag from the Town House for the month of June.

The Board discussed the requests and the fact that this group has a task force in place. The stage and restrooms will be in place as the fireworks will be the day before and these items will already be there.

## DRUG ABUSE & PREVENTION COUNCIL

Tammy Jacob Schulman is Lewisboro's representative for the Drug Abuse & Prevention Council. She shared the last 3 years of programming that the Council has done for 2019, 2020 and 2021.

Most of the programming has been done as webinars. The Town of Lewisboro used to give approximately \$13,000 about 10 years ago and that was reduced to \$6,500 due to hard times that Lewisboro fell on. Bedford pays \$29,000 and Pound Ridge pays \$13,000 and all towns share the programs. She also stated that in 2019 they lost their student assistant counselor in the John Jay High School. The DAPC is currently restructuring.

Sally Corbochuko stated we have had a pandemic within a pandemic. Mental health professionals are completely overwhelmed. She went over topics that are covered and she hopes that a few town officials attend their meetings. She would also like a table at Pride Day.

## **TOWN EVENTS**

A resident feels that the Board is taking a stand on certain serious and important issues, and he is pleased with that. He feels it is more than money – because in his mind \$1,000 is not a lot of money.

Another resident believes the events talked about this evening are important but now we do not have a structured clear policy, and this will be a problem in the months to come. She stated that the Veterans asked for money for the flagpole however they were turned down and had to raise the money. She feels without the Veterans none of these events would be able to take place. During the polling of the board, Supervisor Gonçalves stated the Veterans asked for a flagpole and they were offered the flagpole from the Goldens Bridge Community House, but it was determined that it would be cheaper to get a new one and donations had already been given. The town does support the Veterans and will continue to do so.

Another resident thanked the board for their support for the Juneteenth celebration.
