Supervisor Gonçalves called the meeting to order at 7:30 p.m.

EMERGENCY PROCEDURE

Supervisor Gonçalves noted the exits to be used in the event of an emergency.

The Supervisor led the Pledge of Allegiance to the flag.

<u>PUBLIC HEARING</u> – Proposed Amendment to Chapter 212, Vehicles and Traffic; 1 stop sign to replace Yield sign (7:32 – 7:52 p.m.)

Supervisor Gonçalves called the public hearing to order for a proposed local law of the Town Code of the Town of Lewisboro with regard to the proposed Local Law to amend Chapter 212, of the Town Code of the Town of Lewisboro entitled "Vehicles & Traffic" specifically Subsection 212-8 entitled "Schedule V (212-26): Yield Intersections" is hereby amended to remove said yield sign at the intersection of Hall Avenue and Pond Street and to amend subsection 212-7 entitled "Schedule IV (212-25) to add a stop sign on Hall Avenue at the intersection of Hall Avenue and Pond Street. There was no objection to the time or form of the public notice (attached).

Resident Daniel Ninivaggi, who has lived on Pond Street at this intersection for 3 years is shocked at the lack of traffic signage. He feels that there is significant traffic on this dirt road, and it also creates massive dust clouds. He feels that a 3-way stop sign at this intersection will help.

Supervisor Gonçalves stated that he again reached out to the Police Chief and the Highway Superintendent, and they again held firm on their opinions about this intersection:

From Chief Alfano: My position still remains the same. The speed limit has been lowered to 25mph. The Lewisboro Police Department hasn't had any complaints, accidents, or requests for digital speed signs to obtain data since I've been here.

Most drivers are reasonable and prudent. An unwarranted stop sign installation reduces speed only immediately adjacent to the sign. In most cases, drivers accelerate as soon as possible, to a speed faster than they drove before stop signs were installed. Stop signs are NOT effective for speed control. This particular location will be a breeding ground for disrespect to all traffic control devices and increase running of stop signs.

From Highway Superintendent Peter Ripperger: I still think the only change would be to replace the yield sign with a Stop sign. A three way stop intersection will only cause frustration and abuse with drivers. I feel this would be the wrong use of stop signs. They should never be used for speed control.

Resident David McDonough, a 9-year resident of Hall Avenue stated that he agrees with Mr. Ninivaggi. Mr. McDonough is a board member of the community association and they all voted in favor of pursuing a 3-way stop at this intersection. With the increase in commercial traffic in the last 5 years, he feels there is a need for a 3way stop at this intersection.

Councilwoman Rendo asked if now since this has been brought to the town's attention and nothing is done, will this be putting the town at risk. She suggested that a town engineer do a traffic study and come up with a plan for this intersection.

Councilman Welsh feels that in this case a stop sign is serving as a signal to slow down. He feels that this worked well on Chapel Road and sees no harm in moving forward with the 3-way stop sign at this intersection.

Supervisor Gonçalves stated that they also put a 3-way stop on Todd Road as well. He also understands the suggestion for an engineer report but that is a large expense that would cost more than 3 stop signs.

LOCAL LAW # 5 OF THE YEAR 2022

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF LEWISBORO, COUNTY OF WESTCHESTER, STATE OF NEW YORK AS FOLLOWS:

SECTION 1 : AUTHORITY

This chapter is adopted pursuant to the authority, of Article 2, §10 of the New York State Municipal Home Rule Law.

SECTION 2 : AMENDMENT OF CHAPTER 212

Chapter 212 of the current Code of the Town of Lewisboro entitled "Vehicles & Traffic", specifically Subsection 212-25 entitled "Schedule IV: Stop Intersections" is hereby amended to add the following as stop intersection(s):

STOP SIGN ON	AT INTERSECTION OF	DIRECTION OF TRAVEL
HALL AVENUE	POND STREET	WEST
POND STREET	HALL AVENUE	North
POND STREET	HALL AVENUE	South

SECTION 3 – HOME RULE

Nothing in this Local Law is intended or shall be construed to limit the home rule authority of the Town under State Law or to limit the Town's discretion in setting fees and charges in connection with any applications requiring Town approval.

SECTION 4 – SEVERABILITY

If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part or provision or application directly involved in the controversy in which judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the Town Board of the Town of Lewisboro hereby declares that it would have passed this Local Law or the remainder thereof had such invalid application or invalid provision been apparent.

SECTION 5-EFFECTIVE DATE

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

PUBLIC HEARING – Proposed Amendment to Chapter 18 Ethics, Code of (7:53 – 8:17 p.m.)

Supervisor Gonçalves called the public hearing to order for a proposed local law of the Town Code of the Town of Lewisboro with regard to the proposed Local Law to amend Chapter 18, of the Town Code of the Town of Lewisboro entitled "Code of Ethics" specifically Subsection 7A to read as follows:

18-7 Board of Ethics.

A. There is hereby established a Board of Ethics consisting of at least three members, to be appointed by the Town Board, all of whom reside in the Town of Lewisboro, and who shall serve without compensation and at the pleasure of the Town Board of the Town of Lewisboro.

There was no objection to the time or form of the public notice (attached).

Supervisor Gonçalves stated that currently there are 3 members on the Board of Ethics, with 2 members being residents and 1 member being a town employee. The proposed local law would be to have all 3 members be residents.

Supervisor Gonçalves asked for comments from the residents.

Resident Simone Petromelis had questions about the ethic committee; has it always been a 3member board, what do they do, how often do they meet, what exactly are they charged with, who are the members, why haven't they acted upon recent situations, do they want a town board

member on the committee or not? She would like the committee to come and address the board for this hearing so the public can understand this committee. She feels that there have been ethics issues for quite some time, but she has not heard from them at all. She feels that this committee needs to be more active, more user friendly and meet more often. She also stated that there are no instructions on how to bring an item to their attention or even how to contact them.

Councilwoman Rendo stated that as the law is now written, it states that there should be 3 members, 2 of which should be residents and 1 town employee. Matters need to be brought to the attention of the Ethics Committee; they cannot bring them up on their own. For many years there has only been 2 members which are residents on the board but there has not been a town employee. One of the members explained that the requirement for a town employee was put in place to have someone with knowledge on what is expected of public servants.

Supervisor Gonçalves stated that when he spoke with one of the Ethics members, he suggested that if an employee was going to be on the Board that it should be an employee with longevity and he suggested Lise Robertson, the Assessor who has 37 years with the town or possibly have an alternate employee.

Attorney for the Town Gregory Folchetti stated that the Board of Ethics is only an advisory committee to the Town Board and that once the ethics board makes a recommendation, it is then turned over to the Town Board.

The Board further discussed the current law and felt that further significant changes should be made. Councilwoman Rendo will work on the amendments and another public hearing will be noticed.
