PUBLIC COMMENT PERIOD

Four residents spoke during public comment period.

BUILDING DEPARTMENT – Understaffed

A resident expressed his frustration with the lack of staff in the Building Department. He stated that on June 1st he paid the Building Department \$7,000 for building permit fees and is still waiting. He has called them regularly and they have always been very professional and responsive to him, however, it is his opinion that they need more staff. He asked the Board to please place this issue on an upcoming agenda for a discussion to hire more staff as soon as possible. Supervisor Gonçalves asked the resident to email him for follow-up.

ITALIAN HERITAGE DAY/COLUMBUS DAY

A town resident spoke as a member of the Garibaldi Society of Lewisboro. He stated that they are finalizing plans for their privately funded celebration. He stated that Councilman Welsh attacked him on social media and feels this can have a chilling effect on free speech. The resident wondered if this was not a Board of Ethics violation.

CELL TOWER PRESENTATION - South Salem (7:53 – 8:56 pm)

Ray Vergati, Regional Manager for Homeland Towers, and Manny Vicente, Founder and President of Homeland Towers, made another presentation to the Board to bring the new board members up to speed with their proposal to erect a cell tower at the salt dome town owned property. The Town now has 6 towers: Leon Levy – Bell Property, Goldens Bridge area on Route 684, Route 123 at the Vista Fire Department, Town Park, Route 138 and Lewisboro Volunteer Ambulance Corp. Three of these towers are Homeland Towers.

Homeland Towers feels that the salt dome property which is located at 81 Spring Street near Route 35 and is approximately a 4.5-acre parcel is the best location for the carriers. The proposed facility would include a ground-mounted pole and there would be capacity for up to four antennas for cell service carriers to be mounted. There would also be an option for a fifth antenna which could be used for the town's emergency services.

Mr. Vergati stated that there are two pole options. A 130-foot-tall monopole or a 135-foot-tall mono-pine tower. He also stated that he was reviewing information that he presented to the Board back on June 22, 2020, and July 27, 2020. Since that time, a third-party consultant, City Scape, was hired by Westchester County to figure out where cell coverage was needed and, in their report, they have identified the salt dome as the best location (see attached drawings). Mr. Vergati stated that this location was flat, and it was within the 100-foot wetland buffer zone. Councilman Welsh stated that in Lewisboro the wetland buffer zone was 150-feet.

Councilman Sklarin asked how they came to select this site. Mr. Vergati stated that they also looked at two other town owned properties. One site is located on Route 35 next to the South Salem Animal Hospital however, one of the carriers rejected the site. The other was in the recycling center behind the Town House at 11 Main Street. They heard loud and clear from the lake community that they did not want this location.

Mr. Vergati went over the two types of poles where each carrier would have a different level and they would be 10 feet apart. He also stated that they just erected a tower in New Canaan, and he'd be happy to take Board members there for a site visit.

Mr. Vicente told the board that he wanted to bring them up to speed with information after presenting 2 years ago. This is the next site in Lewisboro to advance coverage and it is exactly between the two existing cell towers. Coverage comparison maps were shown (see attached). Also, the design type of the pole would be up to Board.

Councilwoman Rendo asked how much revenue the town would receive annually. Mr. Vicente stated Lewisboro would receive 35% of the revenue paid by the wireless companies that would use the cell tower and there would be no investment by the town. She also asked what would happen if the Board declined this cell tower and Mr. Vicente stated they would look for another private site close to this location and if no private site was found, then no tower would be erected. Mr. Vicente also stated the 5G would not work as you need the macrosites in place. The carriers won't invest unless you have the macro coverage which is the backbone of the network.

Councilwoman Shah stated that she is concerned about the cemetery and being respectful during possible construction as this is an active cemetery. They would work with the town and do what they can.

Supervisor Gonçalves stated that he is more concerned about the safety issue without this third tower.

Councilwoman Rendo asked how involved the Antenna Advisory Board has been regarding this cell tower and Councilman Sklarin asked if the AAB can further analyze the coverage maps. Supervisor Gonçalves stated that the AAB Chair was in attendance tonight and that they are working with City Scape and have been in touch with the carriers. The Board would like the AAB to present at an upcoming meeting.

Mr. Vicente asked the Board to look over all the information that has been given to them and get back to them within the next few weeks as to what steps are next. Supervisor Gonçalves stated that they will do that.

town and one carrier is dictating to the town? This makes him a bit nervous. And why would the Board waive the 150' buffer. He also asked about the coverage map. He gets very good coverage now and he is in the low point of the valley. He feels that the coverage map shows ideals, but it doesn't show you the numbers of who is and who isn't covered now. He also mentioned all of the historical buildings in this area that will be affected.

A resident stated that the land where the salt dome is situated and where the cell tower is proposed to be installed was donated to the town by the historic Farvue Farm, that sits across the street. She also asked about the wetland setbacks and stated that the Antennae Advisory Board has not put-up minutes since March of this year and would like transparency.
