<u>COMPREHENSIVE PLAN STEERING COMMITTEE</u> – Update (7:38 – 8:45 p.m.)

Katie McGinn, Chair of the Comprehensive Plan Steering Committee, gave a project update which she referred to as Part II of the quarterly update (see attached).

*Councilwoman Rendo arrives at 8:17 p.m.

Councilman Sklarin questioned who they are referring to when they say "Lewisboro Community" besides residents. Ms. McGinn stated that basically anyone who lives or works in Lewisboro. He also suggested having a weekday workshop opportunity. Councilwoman Rendo stated that the feedback they received was it tends to be difficult for families with younger children to get there on a weeknight. Also, if residents can't make a Saturday workshop then a Sunday evening workshop would work better.

Ms. McGinn stated that during the month of March where things will not be so active, the committee has created three fliers called "Did You Know" about the Comprehensive Plan. She will loop the Town Board in now on all upcoming correspondence.

The Board thanked Ms. McGinn and the entire CPSC for all that they are doing for this project.

<u>WESTCHESTER COUNTY MUTUAL AID</u> – Authorize Supervisor to Sign IMA (8:46 – 8:53 p.m.)

Lt. Harry Tompkins from the Lewisboro Police Department stated that approximately 40 police agencies participate in the mutual aid plan. This is an institution of executive plan 203. With social media, there has been very large pop-up demonstrations, and this is monitored by Westchester County. This plan is very comprehensive, and this would give the town great resources to pull from. He believes that this is a win/win for the town.

LAKES DEPARTMENT OF ENVIRONMENTAL PROTECTION (DEP) SPONSORED <u>STUDY</u> – Discussion (9:24 – 9:33 p.m.)

Supervisor Gonçalves stated that back in 2021, the NYC Department of Environmental Protection funded a grant of up to \$425,000 for the town to complete engineering studies of Lake Kitchawan, Lake Truesdale and Lake Waccabuc. In August of 2022, the NYC DEC and the NYS DEP agreed to funding of \$25 million, which would equate to approximately \$6.25 million for each lake (a fourth lake, Croton Falls, was included from North Salem). This was to determine the amount of phosphorous pollution in these lakes and those studies were done. The next step is to see if it makes sense to handle each septic system individually, or to have a community septic or a wastewater treatment plant. The East of Hudson Watershed Corporation with DEP funds went out to bid and Woodard & Curran won the bid, and they will do a feasibility study and make recommendations. Formation of districts would need to be done and petitions for interest would need to be submitted by at least half of the owners of the assessed area. The State Comptroller would need to approve the cost for district homeowners.

Councilwoman Rendo stated that she has received questions about the costs and funding since the use of the lakes is limited to just those residents. Supervisor Gonçalves stated that special districts through the town would need to be set up because the money that is available is only available to municipalities.

Supervisor Gonçalves just wanted to let the Board know about this as he has been working on it and it is in the very beginning stages.

<u>GRANT</u> – Congressional Grant

Supervisor Gonçalves stated that there is a community project funding program and it is a congressional grant through Michael Lawler. The response/application is due this week on March 15, 2023. Supervisor Gonçalves asked about a potential project that would "uplift Hudson Valley Communities". The Board agreed about several upgrades at the Town Park which would include updated bathhouse, water filtration, pickleball courts, platform tennis, play structure at the pool and these projects would total \$1.6 million. This is tied to the Federal fiscal year, which starts in October. Supervisor Gonçalves will work on this and submit by 6 p.m. on March 15, 2023.

PUBLIC COMMENT – New Business Only

A total of three residents spoke during public comment period.

BUILDING INSPECTOR

A resident asked if the extra duties that were discussed this evening for the Building Inspector (Fire Inspector and Stormwater Committee Member) were included in his salary and the answer was yes.

HOUSING

A resident questioned if sewers were created for the lakes, would it allow for higher density in housing in Waccabuc. It was suggested that he give his input to the Comprehensive Plan Committee during one of their workshops.

<u>OSPAC</u>

A resident questioned whether the Wallace nature preserve has been added to the nature preserves in Lewisboro. During polling of the board it was mentioned that nothing has been done yet, however they are working with OSPAC.

HOUSING MANDATE LETTER

A resident would like to have a copy of the housing letter that Supervisor Gonçalves referred to earlier in the meeting. The Supervisor stated that it will be put on the town's website and the Supervisor will forward that letter to her or anyone else who is interested.

CLAIMS - Authorized for Payment
