Nick Tedrow, a Senior Program Manager from Westchester Power, Sustainable Westchester, made a presentation (see attached). Lewisboro joined in 2016 and currently there are 29 municipalities that are participating in the Westchester Power community aggregation program. NYSEG continues to provide the municipalities with the energy distribution which includes the infrastructure and billing.

Mr. Tedrow explained that anyone that had NYSEG as their supplier was automatically put into this program but can opt out at any time. If anyone had already opted out, they would continue to be out. He stated that currently there are a total of 1,650 customers in Lewisboro.

Mr. Tedrow also explained that they are looking to enter into a new contract earlier this year as the price of energy is lower now compared to last year.

The Board thanked Mr. Tedrow for the informative presentation.

A shuttle will also be running daily to the train station. 4 of the buildings are complete and the final 5th building is underway, which will include an elevator.

CODE OF ETHICS
