WHEREAS, the Town Board of the Town of Lewisboro is undertaking a proposed action which seeks to develop a sanitary sewer collection system and wastewater treatment plant for portions of Lake Waccabuc, Lake Rippowam, Lake Oscaleta, and Lake Truesdale in Lewisboro, NY; and

WHEREAS, the proposed action involves determining the feasibility of the formation of a sewer district pursuant to Article 12-A of New York Town Law and the potential future connection of 305 properties to a new wastewater treatment plant with an estimated capacity for 61,000 gallons per day, such connections being effected via 27,000 linear feet of sanitary sewer main; and

WHEREAS, in accordance with the provisions of 6NYCRR Part 617, the Town Board of the Town of Lewisboro intends to serve as Lead Agency for the SEQRA Review of this Type I Action, and in this capacity, will determine if the proposed action will have a significant effect on the environment; and

WHEREAS, it is the intention of the Lead Agency to undertake a coordinated review of this action.

NOW THEREFORE BE IT RESOLVED, that the Town Board of the Town of Lewisboro hereby designates its intention to serve as Lead Agency for the SEQRA Coordinated Review of this action.

BE IT FURTHER RESOLVED, that the Town Clerk Janet Donohue is hereby directed to circulate this Notice of Intent to serve as Lead Agency, along with the Environmental Assessment Form and associated documentation, to all Involved Agencies, which shall be given thirty (30) days from the mailing of this Notice of Intent to serve as Lead Agency to challenge the Planning Boards's designation.

WESTCHESTER POWER PROGRAM – Renewal (7:50 – 8:11 p.m. & 9:51 – 10:15 p.m.)

## **DISCUSSION**

Councilman Sklarin asked for clarification regarding the electricity program price change notice that went out to the residents that are part of the Sustainable Westchester Power. Nick Tedrow, Senior Program Manager for Sustainable Westchester stated that the current rate for 100% Renewable is 10.179 and now there is a transmission charge being assessed to all electricity suppliers in the state of New York of 0.149 which would bring it up to 10.328. The Standard Product (No Additional Renewable Energy) is currently 8.736 and with the transmission charge of 0.149, it will now be 8.885. The price increase will take effect beginning with the June 2023 utility meter read dates and will remain in effect until the end of the current Lewisboro Electric

Service Agreement ("ESA") on the December 2023 utility meter read dates. Councilman Sklarin stated that the option that residents signed up for was 100% renewable clean power product, however, in the MOA it states that they hope that the product will be 50% renewable energy in the next MOA which Mr. Tedrow stated is due to market conditions. Mr. Tedrow stated that Somers, Lewisboro, North Salem, Pound Ridge and most of Bedford are in the NYSEG service zone. The other 24 municipalities are in the Con Ed zone. Mr. Tedrow stated that they will be doing a lot of outreach to the public explaining the price increases, etc.

The RFP will be going out today and the live auction will be on June 27, 2023. There is no market available for 100% renewable product and they are hoping that there will be 50% renewable product with this solicitation for 2024.

Councilwoman Rendo stated that in the next contract residents are paying more and not getting 100% renewable, but rather 50% renewable. Mr. Tedrow stated that this is just the reality of the market. Mr. Tedrow also stated that Westchester Power will be asking for bids of 12,18, 24 and 36 months looking for the best value for the participants. Councilwoman Rendo also does not understand why the program is a mandatory opt out program.

Currently there are 1,566 accounts and approximately 1,464 are signed up for the renewable energy.

<u>COMPREHENSIVE MASTER PLAN JOINT MEETING</u> – Town Board, Planning Board, Zoning Board of Appeals, Conservation Advisory Council, and Architecture and Community Appearance Review Council (8:11 – 9:50 p.m.)

Valerie Monastra, from Nelson Pope Vorhees, made the following presentation to the Boards and Councils (see attached).

Architecture and Community Appearance Review Council Chair Rose Bonano, Building Inspector Kevin Kelly, Planning Board Chair Janet Andersen, Zoning Chair Duff Price, and Conservation Advisory Council Chair John Wolff were all part of the round-table discussion along with several members from each committee in attendance. They discussed the draft goals and objectives of the Comprehensive Plan (see attached).

The term rural and sense of community was discussed which is in the mission statement. It was felt that nothing drastically needs to be changed in Zoning but it was mentioned that a Zoning subcommittee will meet this summer and more information on that will be forthcoming.

It was agreed that a connection with the past and the history of Lewisboro is important and maintaining the character of the town.

Wetlands and tree enforcement and the health of the environment are also important.

Businesses were discussed and the possibility of creating an economic development committee. It was also mentioned that the need to find something creative to draw people here. What is drawing people here; Sporting tournaments, Preserves, Wolf center. Signage is very important.

The expansion of agriculture and gardening was discussed and giving the farm owners a chance to have multiple ways to create an income.

Housing was discussed including aging in place and having children come back to Lewisboro to live. Maybe a community center or maybe more public transportation. Aging in place is more than just a van; its culture, healthcare, and it is complicated. Also live/work situations such as business on the bottom floor and an apartment on the upper floor could be attractive; a mixed use situation. Multigenerational housing was discussed as well so possible zoning changes would need to be made.

A hazard mitigation plan will also need to be expanded upon.

The group talked about needs versus budget and monies can be obtained via grants as well. The town did receive a \$20,000 grant for the comprehensive plan.

There is still time to make comments. The Comprehensive Plan Committee will continue their work.

WESTCHESTER POWER PROGRAM – Renewal (7:50 – 8:11 p.m. & 9:51 – 10:15 p.m.)

The Board continued their discussion regarding the Westchester Power Program. If residents have already opted out of the program, they do not need to opt out again. There are a total of 44 municipalities and 29 of them are enrolled in the program.

Councilman Sklarin did note that the air conditioning was out again in the courtroom, and he feels that this is unacceptable. Supervisor Gonçalves stated he spoke with the school superintendent regarding this issue today and it was due to a software issue which has been resolved.
