I hope you are doing well.

I am doing the planning for the 2023 Cycle of Support Charity Bike Ride that will take place on Sunday, September 10. The ride starts and ends in Purchase and part of the route takes us through Lewisboro.

There will be approximately 120 riders and they will arrive in small groups starting around 8:30 and the last riders will leave Lewisboro around 11:30.

We are not requesting any road closures, are not using any barricades, riders follow all rules of the road and will use the shoulder or bike lane when available. There will be no impact on normal traffic.

Dear Supervisor Goncalves,

In year 2020, the Lewisboro Police Department received \$40,000.00 from an insurance claim as a patrol vehicle was involved in a motor vehicle accident and was considered a total loss. That money was then placed in 'Other Fund – Special Deposit Account – TA.0000.0085'. Due to supply chain issues and certain vehicle shortages a police truck was unattainable and never purchased in years 2020/2021. In year 2022, I budgeted \$14,200.00 with intentions to combine that with the \$40,000.00 in order to purchase the above-mentioned truck. However, once again I was unable to purchase said truck due to supply chain discrepancies and Chevrolet not taking in special orders. Considering the \$14,200.00 was never utilized in budget year 2022, it is my understanding that the money defaulted into the 'General Fund'.

The Lewisboro Police Department is respectfully requesting a 'Letter of Intent' from the Town to purchase a 2024 Chevrolet pickup truck from Denooyer Chevrolet for the cost of \$53,900.00 by utilizing funds from the \$40,000.00 'Special Deposit Account' and \$13,900.00 from the 'General Fund'.

Denooyer Chevrolet was the winning bid on NYS Office of General Services (bid # 13178).

- 3. 2014 Ford Explorer, VIN # 1FM5K8AR8EGA33530


The vehicles will then be listed on 'Auctions International.' The Town of Lewisboro currently has an active account and there is no cost associated.

2022 MEMORANDUM OF AGREEMENT AMONG THE TOWNS OF SOMERS, LEWISBORO, AND NORTH SALEM, with regard to THE SENIOR CITIZEN NUTRITION PROGRAM

The Town of Somers will provide a Senior Citizen Nutrition Lunch Program meeting the requirements of the Older Americans Act and the rules and regulations of the New York State Office for the Aging for the persons qualifying in the Towns of Somers, Lewisboro and North Salem. Such services will be provided in accordance with the Town of Somers' agreement with the County of Westchester.

The Town of Somers may terminate this Agreement if its arrangement with Westchester County is terminated. If the program is terminated by Westchester County, Somers will promptly notify the supervisors of Lewisboro and North Salem.

The Towns of Lewisboro and North Salem will furnish (1) appropriate insurance in accordance with the requirements of Westchester County, if applicable and (2) proof of insurance and indemnities to Westchester County as might be required by Westchester County.

The Towns of Lewisboro and North Salem will provide the Town of Somers with proof of existing General Liability Insurance containing Broad Form Contractual Liability coverage in the amounts listed below:

> \$500,000 per occurrence for bodily injury \$100,000 per occurrence for property damage

The Town of Somers will provide the Towns of Lewisboro and North Salem with certificates of insurance in like amounts and naming each as an additional insured with respect only to the activities at the congregate site.

If transportation is furnished by the Town of Lewisboro or the Town of North Salem, that town will provide proof of existing Automobile Liability Insurance coverage in the amounts listed below and in which the Town of Somers is named as an additional insured with respect to the Nutrition Program:

\$1,000,000 per occurrence for bodily injury

\$ 100,000 per occurrence for property damage

Nothing arising out of this agreement shall create or give to any third parties a claim or right of action.

The Town of Lewisboro agrees to pay the Town of Somers the sum of \$26,548.95 and the Town of North Salem agrees to pay the Town of Somers the sum of \$19,482.89 as indicated in the schedule below:

It is further understood that the attendance from each town impacts the cash amounts provided for in this Agreement.

In the event extraordinary and unanticipated expenses are incurred by the Nutrition Program, these expenses will be apportioned among the three towns according to percentage of attendance as indicated in the attached schedule for both the WIN, Wellness in Nutrition Program. The period of time covered by this agreement is from January 1, 2022 to December 31, 2022.

Supervisor and Town Board Members,

The Goldens Bridge Hamlet Organization (GBHO) respectfully requests the Town of Lewisboro (Town) waive the usual and customary fees associated with obtaining a building permit and any inherent additional fees required by the Town for the GBHO's Fairmount Corner Pocket Park project.

The GBHO is a 501c3 not for profit community engagement entity and has entered into an agreement with the Town to improve a Town owned property at the sole expense of the GBHO with the full knowledge that the agreement is revocable by the Town. We have maintained all specifics required in the attached agreement including maintaining liability insurance as specified.

We feel it would be a mutually beneficial decision to relieve us of the expense of these fees as we are a 100% volunteer organization entirely funded by donations from the community we aim to serve. The property is certainly benefiting from our efforts already.
