Arbor Hills Water System, 0 Brundige Drive, Goldens Bridge, NY 10526; Sheet 12, Block 11152, Lot 200; Zone R-2A (Liberty Utilities, owner of record) - Application for a new water treatment building.

Ken Gehringer, AIA, and Robert Hein, AIA, were present on behalf of the owner.

Mr. Gehringer stated the proposal is to construct a new 48' x 36' water treatment building. He noted that the structure will:

- be set back from the road;
- be made of dark grey split face concrete block;
- have a pitched green metal standing-seam roof; and

• the mechanicals systems and exhaust fans will not be facing the neighbors' houses.

Indian Hills Water System, 0 Apache Circle, Katonah, NY 10536; Sheet 10, Block 11152, Lot 189; Zone R-1ACON (Liberty Utilities, owner of record) - Application for a new water treatment building

Mr. Gehringer stated the proposal is to construct a new 48' x 36' water treatment building. He noted that the structure will:

- be set back from the road;
- be made of dark grey split face concrete block;

Lewisboro Library, 15 Main Street, South Salem, NY 10590; Sheet 36, Block 10807, Lot 41; Zone SCR-1/2A (Lewisboro Library, owner of record) - Application for two new granite posts.

Priscilla Luckow, Lewisboro Library trustee, was present.

Ms. Luckow stated the proposal is to install two 3' granite posts flanking the southern end of the bluestone walkway in front of the library. She noted parked cars and snowplows have been damaging the walkway. Ms. Luckow stated there is no additional signage proposed and she agrees with the Building Inspector's recommendation to stripe the walkway access area in the parking lot. She noted that other parts of the parking lot need to be restriped.

Mr. Mercer made a motion to approve the two new 3' granite posts at the southern end of Lewisboro Library walkway, 15 Main Street, South Salem, as submitted; seconded by Mr. O'Hara; In favor: Rose Bonanno, Darren Mercer and Steven O'Hara. Absent: Chris Winter.

Arnold Residence, 28 Main Street, South Salem, NY 10590; Sheet 31, Block 10805, Lot 19; Zone SCR-2A (Barbara & Stephen Arnold, owners of record) - Application for a new screened-in porch.

Barbara Arnold, owner, was present.

Ms. Arnold stated the proposal is to construct a new 24' x 24'2.5" screened-in porch with two doors at the rear of the house. She noted the structure's floor is to be tan, the frame beige and the roof black to match the house.

The Council discussed lighting; there is a floodlight beneath the gable and a scone on one side.

Mr. O'Hara made a motion to approve the new screened-in porch at the Arnold Residence, 28 Main Street, South Salem, as submitted; seconded by Mr. Mercer with the with the condition that a variance be granted by the ZBA and a building permit is issued; In favor: Rose Bonanno, Darren Mercer and Steven O'Hara. Absent: Chris Winter.
