" This past Thursday, August 24, 2023, our former Comptroller Leo Masterson passed away at the age of 66. Our deepest condolences go to Leo's family including his wife Lori and children Andrew and Sara.

The Town of Lewisboro has lost one of its greatest assets and he will be deeply missed by all who benefitted from his tremendous work ethic, financial acumen, inherent decency, and marvelous sense of humor.

I personally am grateful for Leo's support when I served as Town Councilman and most recently as Town Supervisor. I appointed Leo as my Deputy Supervisor in January 2022. We worked very closely over the past couple of years, and I learned quite a bit from Leo. At the end of 2022 and early this year Leo had to focus on his health but was still able to dedicate time to help me with our Town's 2023 budget including understanding all the intricacies of municipal finances. Leo made himself available to the Town earlier this year to make sure the transition to our new Comptroller was seamless. My last interaction with Leo was late June when he came to the Town House to assist our new Comptroller. I was hoping we would see more of Leo, but God had other plans for this great man."

WHEREAS, during his tenure, the Planning Board oversaw significant changes to important commercial enterprises, including; Lewisboro Library expansion, creation of Thistlewaithe Learning Center, Day Care center at Oakridge, conversion of Le Chateau to a banquet facility, storage facility in Vista, Goldens Bridge Center and a site redesign of Mercedes Benz; and

WHEREAS, other important community facilities were approved while JEROME KERNER served as chair of the Planning Board, including dry hydrants for the Town fire departments, Eagle Scout projects, and changes to the Town Parks; and

TREE ORDINANCE - Discussion (7:55 – 8:30 p.m.)

The Board continued their discussion regarding finalizing updates to the current tree ordinance and setting a public hearing.

Supervisor Gonçalves stated that the only change in language that he would suggest is that a homeowner be able to cut down a tree on their own. He stated that if the homeowner hires a tree removal company, that company would need to be licensed.

Councilwoman Rendo feels that the revised ordinance including three sentences and a website link explaining how a homeowner can determine if a particular tree service company was licensed by the county is unnecessary and can shortened. Councilwoman Rendo also feels that homeowners needing to list the trees and get approval to remove trees for construction is overreaching and would like to see this language revised. She also feels that a homeowner should be allowed to replace trees as opposed to paying a fine.

Supervisor Gonçalves stated that the Conservation Advisory Council Chair John Wolff proposed these changes because a resident making improvements to their home clear-cut their trees and this is what they are trying to avoid.

Councilman Sklarin feels that the way it is drafted is ambiguous. He feels that the language in the proposal does not specify who would determine unlawful damage. There is also no timetable for restoration in the revised ordinance.

The Board continued their discussion and it was decided that changes would be made to the latest revision of the tree ordinance and an updated draft would be circulated in the near future and a public hearing would be scheduled for the October 23, 2023 Town Board meeting.
