<u>ISRAEL</u>

Our hearts go out to all the families and loved ones affected by this devastating event."

We followed with a moment of silence for the lives lost and their families.

Supervisor Gonçalves also announced that due to the conflict in Israel, Altice (Optimum) was allowing all calls and texts to be made free of charge.

A total of 3 residents spoke during the public comment period.

LIONS CLUB FUNDRAISER

A resident and member of the Lewisboro Lions Club spoke about the upcoming fundraiser and spoke about the history and motto for the Lions Club.

EV CHARGING STATION IN GOLDENS BRIDGE SHOPPING CENTER

A resident suggested that the Board do a formal site visit to the Goldens Bridge Shopping Center where the EV charging stations are located and suggested they do this visit in the evening. She stated that it is an eyesore and is very, very bright and is shocked that this was even approved. She is hoping something can be done to mitigate the green glow coming from the area.

During the polling of the Board Supervisor Gonçalves stated that these fast chargers are very bright, and the manufacturer has been contacted to see what can be done. The chargers are available 24/7.

COLUMBUS DAY

A resident felt that the Supervisor missed an opportunity to say something kind about the Italian Americans and what they have done for this country.

ISRAEL FLAG

A resident stated that she is sickened by what Hamas has done to Israel. She sees that the town has been flying the Ukraine flag at the Town House and feels the town should also be flying the Israel flag.

WESTCHESTER EMS ALS FLY CAR BUDGET – Presentation (8:14 – 8:47 p.m.)

Al Kim, the Executive Director of Westchester Emergency Medical Services made a presentation to the Board regarding adding a fourth Emergency Medical Services Advanced Life Services fly car to the budget (see attached). These ALS fly cars service Bedford, Lewisboro, Mt. Kisco, New Castle, North Castle, North Salem, Pound Ridge and Somers.

Mr. Kim did state that they have not added an additional car in 22 years, and he would not be requesting this now if he did not think it was necessary. He explained that the Lewisboro Volunteer Ambulance Corp has emergency medical technicians, and the fly car has paramedics.

After some discussion it was decided that the board would approve an increase with a new car and related manpower for half a year.

PUBLIC HEARING RESET ANNOUNCED - Chapter 203 Tree Preservation

Councilwoman Rendo stated that she felt all 3 options had pros and cons however, she was leaning towards options 1 and 3, although she has also heard that seniors would like more accessibility in town.

Supervisor Gonçalves stated he was leaning towards option 2 as accessibility has already been started with the Lewisboro Town Park Playground.

Councilwoman Shah asked if they choose to do two options, what the extra cost would be and Katie McGinn, Chair of the Comprehensive Master Plan stated she would have to reach out to Star Whitehouse to find out. Councilwoman Rendo asked if there was the possibility of a hybrid for options 1 & 2. Ms. McGinn said that they certainly could do this, however it would cost additional money and take additional time.

The Board did agree with going with option 2, access and inclusion guidelines for public spaces.

NOW THEREFORE BE IT RESOLVED, that pursuant to 6 NYCRR Part 617, State Environmental Quality Review, The Town Board of the Town of Lewisboro, hereby designates itself Lead Agency for the SEQR Review of this Unlisted Action, and

BE IT FURTHER RESOLVED, that pursuant to Part 617 of the implementing regulations pertaining to Article 8 (State Environmental Quality Review Act) of the Environmental Conservation Law, the Lead Agency has determined that the proposed action will not have a significant adverse impact on the environment for the reasons enumerated in the referenced EAF and the Notice of Determination of Non-Significance attached hereto and made a part hereof.

Description of Action:

The Town of Lewisboro Town Board has adopted a bond resolution, subject to a permissive referendum, to design and construct pedestrian improvements within three (3) of the Town's

hamlets, Goldens Bridge, Cross River, and Vista. If approved, the bond would be in the amount of \$2,100,000. The desired pedestrian improvements have been conceptualized; however, formal designs have not yet been prepared. All proposed improvements will be located within New York State Department of Transportation (NYSDOT) rights-of-way and each of the three (3) projects will require NYSDOT input and approval. A description of each project is provided below:

<u>Goldens Bridge</u> - Provide crosswalks at the signalized intersection of NYS Route 138 and North Street and a sidewalk along North Street from the MTA parking lot /shopping center driveways to NYS Route 138.

<u>**Cross River**</u> - Provide crosswalks at the signalized intersection of NYS Route 35 and NYS Route 121; provide a sidewalk(s) along Route 121; provide a crosswalk across Route 121 at the northern limits of the project area, in the vicinity of the property line between John Jay schools and the shopping center.

<u>Vista</u> - Provide a bike lane along Route 123 between Glen Drive and the entrance to the shopping center; provide a crosswalk across Route 123 at the entrance to the shopping center.

Location: Hamlets of Goldens Bridge (NYS Route 138/North Street); Cross River (NYS Route 35/NYS Route 121); and Vista (NYS Route 123)

Reasons Supporting This Determination: Reference is made the Short Environmental Assessment Form (EAF), dated September 14, 2023. The Town Board has compared the proposed action with the Criteria for Determining Significance in 6 NYCRR 617.7 (c). Specifically:

1. The proposed action will not result in a substantial adverse change in the existing air quality, ground or surface water quality or quantity, traffic or noise levels, or a substantial increase in solid waste production.

The proposed action involves linear improvements along or withing existing NYSDOT roadways. The project areas are either already developed with road surfaces or consist of already disturbed roadway shoulders within the NYSDOT right-of-way. The project will not result in a significant amount of new impervious cover and will not result in significant tree or vegetation removal. Stormwater runoff from any new impervious cover, such as from new sidewalks along existing roadways, will be conveyed to already established NYSDOT drainage systems. If new or supplementary drainage systems are required to accommodate runoff, they will be designed during the design phase and would be subject to NYSDOT approval. Wetlands and watercourses located in the vicinity of the project areas will be protected during construction via the establishment of erosion and sediment control practices, such as silt fencing and inlet protection. No direct wetland or watercourse disturbance or impacts will result.

The proposed action will result in pedestrian safety improvements, such as sidewalks and crosswalks, which do not presently exist. The project will not result in additional traffic.

Construction-related traffic is expected but will be temporary. During construction, there may be a temporary increase in construction related traffic and noise levels, however, once the project is completed, noise levels are expected to be similar to levels prior to construction. Constructionrelated noise is regulated under Section 220-60 Noise, of the Town of Lewisboro Town Code.

The project will have no significant impact on air quality, groundwater, or solid waste.

2. The proposed action will not result in the removal or destruction of large quantities of vegetation or fauna; substantial interference with the movement of any resident or migratory fish or wildlife species; impact a significant habitat area; result in substantial adverse impacts on a threatened or endangered species of animal or plant, or the habitat of such species; and will not result in other significant adverse impacts to natural resources.

The project areas are located on or along already developed or previously disturbed land consisting of NYS roadways and rights-of-way. Limited tree and vegetation removal will be required. When preparing EAF, the NYSDEC Environmental Resources Mapper was utilized which indicates that there are no significant natural communities or rare plants or animals on, or in the vicinity of the project sites.

3. The proposed action will not result in the impairment of the environmental characteristics of a Critical Environmental Area as designated pursuant to 6 NYCRR Part 617.14(g).

The subject property is not located within a Critical Environmental Area.

4. The proposed action will not result in a material conflict with the Town's officially approved or adopted plans or goals.

The proposed action is consistent with the Town's plans and goals for pedestrian improvements and safety within the hamlet areas.

5. The proposed action will not result in the impairment of the character or quality of important historical, archaeological, architectural, aesthetic resources, or the existing character of the community or neighborhood.

The project areas are not located within or contiguous to a National or State-listed historic or archaeological resource; the project areas are not located within a mapped archeological sensitive area. The improvements are proposed on already developed or disturbed lands consisting of existing NYSDOT roadways and shoulder areas. Proposed improvements will consist of pavement striping, asphalt paving, concrete sidewalks, and similar materials typical of a roadway setting.

6. The proposed action will not result in a major change in the use of either the quantity or type of energy.

No change of use is proposed, and the project will not result in a change to the quantity or type of energy used.

7. The proposed action will not create a hazard to human health.

The project involves pedestrian safety improvements along NYSDOT roadways which will be implemented to improve or safeguard human health.

8. The proposed action will not create a substantial change in the use, or intensity of use, of land including agricultural, open space or recreational resources, or in its capacity to support existing uses.

The proposed action will not result in a change of use and not agricultural, open space or recreational resources will be impacted.

- 9. The proposed action will not encourage or attract a large number of people to a place or place for more than a few days, compared to the number of people who would come to such place absent the action.
- 10. The proposed action will not create a material demand for other actions that would result in one of the above consequences.
- 11. The proposed action will not result in changes in two or more elements of the environment, neither of which has a significant impact on the environment, but when considered together result in a substantial adverse impact on the environment.
- 12. When analyzed with two or more related actions, the proposed action will not have a significant impact on the environment and when considered cumulatively, will not meet one or more of the criteria under 6 NYCRR 617.7(c).
