Approximately 6 residents/observers attended the live meeting and approximately 14 participated via Zoom.

Supervisor Gonçalves called the meeting to order at 7:30 p.m.

#### EMERGENCY PROCEDURE

Supervisor Gonçalves noted the exits to be used in the event of an emergency.

#### PLEDGE OF ALLEGIANCE

The Supervisor led the Pledge of Allegiance to the flag.

#### **COMMUNICATIONS**

There were no communications.

#### PUBLIC COMMENT PERIOD I

A total of 6 residents spoke during the public comment period.

# **ELECTIONS**

Residents congratulated all that were elected back to office.

# PFAS CLASS ACTION LAWSUIT

A resident asked if the class action suit would be discussed later in the meeting and the answer was yes.

# EV CHARGING STATION IN GOLDENS BRIDGE SHOPPING CENTER

A resident again spoke about the brightness of the EV charging stations in the Goldens Bridge Shopping Center. She stated that not only do they have detrimental effects on the environment but after reading many articles regarding the installation of these chargers, none mentioned that the brightness was a technical need. Reasons given by several sources were safety of the equipment,

safety for people using the equipment and easily identifiable by motorists looking for a charging station. Since most electric car users utilize apps to locate chargers when traveling, reason #3 seems like a moot point. She also stated that fast chargers are detrimental to the batteries.

During polling of the board, Supervisor Gonçalves stated that he reached out to the property manager at the Goldens Bridge Shopping Center and they are reaching out to the manufacturer.

#### OAKRIDGE WATER

A resident spoke about how the water in Oakridge is still not safe to drink and has been talking about this for the past four years.

During polling of the board, Councilman Sklarin asked if there were any specific test results that could be shared, he would be happy to take a look at it.

# SOLAR PANELS ON CARPORT AT ONATRU

Three residents commented about the proposed carport and solar panels being built at Onatru Farm. While they support the use of solar panels as clean energy, there is an overriding issue constructing anything new unless it is recreational related. Portions of the deed were read.

During the polling of the board, it was mentioned that they heard everyone loud and clear. They were over at Onatru Farm today looking at other options. It was suggested that possibly the solar panels could go on an existing roof, and they have been in contact with the Garden Club.

#### HOLIDAY CELEBRATION

A resident stated that he doesn't understand why we don't call the holiday tree in town a Christmas Tree. He stated that he would not call the Jewish religious symbol, the Menorah, a holiday candle. He hopes that we can get back to calling it a Christmas Tree.

Another resident stated that prior to COVID, she and another resident brought up "Unity back in the Community" with a Winter Wonderland Celebration. She feels we should have one unified celebration, for Christmas, Hanukkah, Kwanza, Diwali, etc. She would like to see this start in 2024.

During polling of the board, it was discussed that Christmas Tree would be used.

#### COMPREHENSIVE MASTER PLAN – Set Date for Workshop

The Board discussed possible dates, times and locations for the Comprehensive Master Plan Public Workshop. The Board suggested either an early evening on a Sunday or a Monday evening in January when the Town Board was not meeting. The meeting would also be a hybrid of live and Zoom and possible locations that were mentioned were the Town House or the Library. Supervisor Gonçalves will follow up with the CMP Chair and report back to the Board.

# <u>BUDGET 2024</u> - Discussion (7:50 – 8:28 p.m.)

Supervisor Gonçalves stated that the 2024 Tentative Budget that he presented to the Board dated October 11, 2023 is at the tax cap rate of 2.57%. The proposed tax levy for 2024 is \$8,435,932; Net tax increase is \$211,443 from 2023. To get to the tax cap, \$450,000 was removed from paving and is proposed to Bond in 2024. Proposed borrowing request will be further discussed with the Town Boad but the options are as follows:

- 1. place back into the budget resulting in a tax rate increase to 8.06% or
- 2. borrow in which case the debt service will be reflected in the 2025 budget but less of an impact to the taxpayer if the full amount were to be included in the 2024 budget

Road resurfacing line is \$180,000 for 2023 and now for 2024 the budget is \$50,000 and Councilman Welsh is stating that we are losing ground. Councilwoman Rendo reiterated that if they go the bonding route, the \$450,000 would be bonded for early next year. By the time those bonds are issued, other debt services will be coming off. The CHIPS are budgeted at \$300,000 is looked at as bonus money. So, the total allocation for roads would be \$900,000. Councilman Sklarin feels that the remaining ARPA funds of \$535,000 should be looked at and used partially for road resurfacing. Councilwoman Rendo said they all have their opinions on what these ARPA funds should be used for, and they should have an additional work session to discuss this. Some ARPA money has already been allocated.

Councilwoman Rendo stated she feels that we should have a 5- or 10-year plan. She would not be opposed to breaking the tax cap slightly so the resurfacing line would increase a bit in the budget and then they could bond for the rest. She feels that this would be a compromise for the \$450,000 and will continue to do this in the coming years. This is a long-term goal. She also stated that they have to look at which roads should be ground down as opposed to layering.

Councilwoman Rendo also suggested that since all of the non-union employees are slotted for a 4% increase, the incoming Highway Superintendent should also be slotted for a 4% increase. She stated that he is the only one not receiving a raise. Councilman Sklarin stated that the incoming highway superintendent was given the salary, which was \$113,495, and he accepted the job at that salary. Councilwoman Rendo would like to sit down with the Comptroller to understand this budget and to see what would happen if these or other changes were made.

Town Attorney Gregory Folchetti explained that the Preliminary Budget has to be adopted tonight as public notice will need to be in the paper this Friday. Included in the public notice are the salaries for Town Supervisor, Town Board, Town Clerk and Highway Superintendent. Mr.

Folchetti stated that you cannot increase the salaries once they have been published. The salaries can be reduced; however, you cannot increase the salaries without legislation.

The Board did decide to leave the tentative budget as it was and that became the Preliminary Budget.

#### IMA AGREEMENT AND LICENCE AGREEMENT - Police

Supervisor Gonçalves stated that Westchester County has received state funding for the new triband radio system. These new radios will allow interoperability between the county, state and emergency response agencies. Chief Alfano has been testing different radios for about a year and decided on Motorola. He stated that the county has been talking about providing radios to the municipalities for the past 3-4 years. The Chief learned about a grant that he applied for and he should be hearing very soon about how many radios his department will receive. He did state that he told them he has eight police vehicles and hopes to receive one for each vehicle. These radios would cost approximately \$4,000-\$6,000 per radio.

Mr. Lauder also donated \$40,000 towards these radios.
