Mr. DeLucia stated that the Parks & Recreation Superintendent, Dana Mayclim, put together a memo to the Board regarding her department's numbers to date but he hasn't had a chance to discuss this with her. He would like clarification on this memo.

He does know that there was a savings of \$35,000 in salaries of counselors and directors. There may be other savings such as the purchase of less movie tickets, etc.

Mr. DeLucia also stated that we sold some life time permits, rented some pool time, renting the fields, etc. So Mr. DeLucia feels that the -\$70,000 will be lower.

Mr. DeLucia also wants some capital expenditures looked at such as life guard shares, etc. at the pool.

Mr. DeLucia stated that the town is losing a lot of revenue with children getting older and parents not wanting to purchase the full permit for the pool. Mr. DeLucia also stated that we currently don't have an avenue for school district kids to go to the pool so he and Ms. Mayclim are working on a solution which includes a book of ten tickets for a set higher price than what our residents pay.

Mr. Masterson stated expenses seem to be running for the most part on budget. The Planning Board attorney fees may be about \$20,000 more than budgeted due to lawsuit activity. The court clerk's salary will be higher than budgeted. And the final area is the rent at Cross River. When the police moved in the square footage changed and the lease rent also went up. Mr. Masterson paid the increased rent about 4 months too late and they have now charged us for the shortfall.

Mr. Masterson then talked about the police department in general. By the end of the year, with the transitions that are being talked about, the actual expense will be less than what is budgeted, however, it is only a 4 month period. Overtime (OT) at this point is running about 80% of this year's budget. Mr. Masterson is hopeful that this number will be more in check by the end of the year.

The Board thanked Mr. Masterson for his report.

Mr. Parsons stated that we are short with our target of paved roads. Mill River Run took about 100 tons more than we anticipated. Michelle Estates did receive a thin layer over their road. A series of roads off of Increase Miller have been done. The town will have to come back to do Manor and Deer Track and Billingsley Trail.

Mr. Parsons also stated that the Cornell intern will update the Town Board on our roads at the next Town Board meeting. He will report on what he feels should be done to our roads in the next five years.
