#### NO PARKING ON PARK ROAD - Resident Comment

Mike Alterio of Park Road made three comments regarding the no parking on Park Road.

- 1. Mr. Alterio stated that the parking ban was not headed up by the WOTOA but rather by the President as a private citizen.
- 2. Thanksgiving is approaching and they will have many guests. Mr. Alterio feels that the parking on the courts will be full. Where will all the guests park?
- 3. Mr. Alterio stated that no other roads have a parking ban. He would like the Town Board to rescind the parking ban on Park Road at the next Town Board meeting.

## BLACK MANSION - Clean Up Crew

Supervisor Parsons thanked the following volunteers who cleaned up the Black Mansion ruins which he stated is the centerpiece of the Leon Levy preserve: George Scott, Tim Farrow, Paul Lewis, Michael Surdej, Randy Price, Shiela and Amir Lesensky. Ms. Crimmins will be sending "Thank You" notes to those volunteers.

## TOWN HOUSE – Move to 79 Bouton Road

Supervisor Parsons stated that the Town House offices will be moving, temporarily, to 79 Bouton Road (the former Lewisboro Elementary School) for approximately 6 months while upgrades are being made to the Town House. Supervisor Parsons stated that the Receiver of Taxes will move on or around November 2nd, the Town Clerk will move on or around November 15<sup>th</sup>, and the Supervisor, Supervisor's Secretary and Comptroller will move on or around December 1<sup>st</sup>, 2018.

#### PARKING ON PARK ROAD - Resident Letter

Dear Supervisor Parsons; Lewisboro Town Board Members Tony Goncalves, Dan Welsh, Jane Crimmins and John Pappalardo; and Town Clerk Janet Donohue:

*Please include this letter as part of the official public record for the October 22, 2018 Lewisboro Town Board meeting:* 

I request that the issue of and the vote on restoring the much-needed parking along Park Road in Goldens Bridge be added as an agenda item to the Town Board meeting scheduled for the beginning of November 2018.

Icy roads create perilous walking conditions along Park Road for the visitors and residents of the WOTOA townhouses who can no longer park close to their destination, so it is important to schedule this agenda item prior to the arrival of inclement winter weather.

The Town Board must not abdicate its responsibility to reexamine the parking ban. Board members need to examine and debate the factual information around safety (the reason given for the ban), the community's need for parking on this road, and reexamine the April 9th decision to single out Park Road and ban parking. I respectfully urge the Board to review, listen, respond and, most importantly, correct the neighborhood problems and animosity created by the unnecessary parking ban and to act to restore parking and harmony to the Wild Oaks neighborhood.

#### Some facts:

The Board's decision should not be made on the "one moment in time" number of signatures on a petition, but should be a decision supported by the facts about safety and the community's long term parking space needs.

#### However, for the record:

• Over fifty percent of the signatures on the petition to ban parking presented on March 12th were from residents of The Glen subdivision who live on a private road (Park Road Extension) with adequate private parking.

• Residents living on the courts off of Park Road were not informed of the extra cars that would be parking in front of their units and some are understandably angry.

• More WOTOA residents signed the petition to restore parking than the number that signed the factually misleading petition, circulated by a few residents, which asked for limited parking or a ban on parking. Four of WOTOA residents rescinded their signatures on the petition to ban and signed the petitions to restore parking presented to the Board on July 9th.

• Park Road is a dead-end street with limited traffic and no history of accidents in over 30 years. The Lewisboro Chief of Police reported that there have been no vehicular accidents in his five-year look-back.

• Emergency vehicles can easily drive by cars parked along one side of Park Road. They have been doing so for decades.

• Parking availability was inadequate before the ban. The ban reduced the available parking spaces from 33 to 21 - all located on the three courts off Park Road. Current best planning practices of 1.5 parking spaces per bedroom would require - taking the 31 garages near Park Road into account, 62 parking spaces for the townhouses located along Park Road. Even with the approximately 13 spaces on Park Road there was a parking crunch.

• Parking needs change over time. Although one person with one car may be currently living in a unit, two-years from now, the unit could be sold and occupied by three adults with three vehicles. Best planning practices allow for these contingencies.

Persons impacted by prohibiting parking on Park Road - here are a few:

• The family and friends driving from Cross River, New Jersey, Long Island, Katonah, Somers, South Salem, etc. who wish to visit the residents of the Wild Oaks Townhouses.

• The workmen who provide services for WOTOA residents.

• The resident with a two or three car household.

Thank you for your time. We need and deeply appreciate your help restoring peace to our neighborhood.

BUDGET – Library (8:20– 8:34 p.m.)

Lewisboro Library Director Cindy Rubino discussed her budget with the Town Board and she stated that the Town of Lewisboro spends less per capita than any other town, city or village on our library. Ms. Rubino also introduced Colleen McLafferty, a library trustee and Kevin Fitzmartin, the library's treasurer.

Ms. Rubino stated that they have had a good year. Attendance has increased in most programs. The majority of the library's money comes from the Town and they fundraise the rest. They are asking the Board for a 3.62% increase this year. Ms. Rubino stated that with the requested increase, the library's total income would be \$551,402 and the total expense would by \$557,937 which would leave a difference of \$26,535 of which they hope to fill with additional fundraisers.

The Board complimented Ms. Rubino on a job well done. Mr. Pappalardo also expressed that he likes the template that the library uses for their budget.

BUDGET – Discussion (8:35 – 9:08 p.m.)

Comptroller, Leo Masterson, went over the requested 2019 Budget for the town and stated that the proposed tax increase versus the 2018 tax levy was \$633,000. The tax cap for the town is \$156,000 so the town would be over the tax cap by about \$475,000.

Mr. Masterson stated that revenue in the general fund decreased by approximately \$200,000. In 2018 the town budgeted for \$171,000 for the sale of town owned property, however, there is nothing budgeted for 2019. He stated that Parks and Recreation revenue is projected to decrease by about \$55,000 and that tax interest and penalties he suspects will decrease by about \$30,000.

Mr. Masterson stated that the tax office moved to an online payment system which he believes has increased the flexibility that tax payers have so they are making payments now that they would have been late on in the past. He also stated that the economy has improved and more people are paying on time.

Mr. Masterson stated that there was a last minute change to the court fines and bail line decreasing it from \$230,000 to \$200,000.

There is also a \$26,000 decrease in Medicare Part D fees that the town collects due to a shift to the NY State Health Insurance Plan for medical coverage of town employees but he explained that the move to NYSHIP would generate more than a \$26,000 reduction to expenses.

The Building Department fees are projected to be \$50,000 greater than 2018. Mr. Parsons stated that the Town had not been collecting late fees to which it was entitled and he was not sure why but he pointed out that if the town employed a Code Enforcement Officer it could increase those fees.

Mr. Masterson stated that included in the budget is \$158,000 in funds due to the fund rebuild which he explained has been instrumental in prior years in recouping the fund balances in both the general fund and the highway fund. He said it would be up to the Board if they still wanted that amount in next year's budget and if they chose not to include this amount, they would be about \$325,000 away from the tax cap.

Mr. Pappalardo asked if the Town was planning on capturing any revenue in 2019 from foreclosed properties. Town Attorney, Anthony Molé stated that it was doubtful sales would be at or near the same level as this year. Supervisor Parsons stated he did not have a chance to review foreclosed properties but said there could be one that could be valuable if sold.

Mr. Masterson stated that he left the mortgage tax even for next year however a decline in those revenues was possible.

The Board thanked Mr. Masterson and stated that they will continue to reduce expenditures off of this budget. The Board also decided to set a public hearing for the possibility of overriding the state tax cap.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board of the Town of Lewisboro request that the PSC immediately consider NYSEG's application for smart meters and expand NYSEG's power to cut any trees which threaten the power supply; and

BE IT FURTHER RESOLVED, that the Town Board of the Town of Lewisboro calls for an immediate Independent Assessment (IA) of NYSEG, ordered by the Public Service Commission, contracted and overseen by Westchester County Government and paid for by NYSEG, so that 'best practices' regarding the safest, most technologically advanced, reliable delivery of power is implemented, and that promises by NYSEG of better responses, fewer outages and upgrades of hardware actually occur.
