## LOCAL LAW NUMBER 5-2019 OF THE TOWN OF LEWISBORO

#### **SECTION 1 -- TITLE**

This Local Law shall be known as 2019 Amendments to Section 212-25 Schedule IV: Stop Intersections, and Section 212-26 Schedule V: Yield Intersections, of Chapter 212: Vehicles & Traffic.

#### **SECTION 2 -- ADOPTION**

Now therefore be it enacted by the Town Board of the Town of Lewisboro Local Law 5-2019 that this law shall take effect immediately upon filing with the Secretary of State:

## SECTION 3 – VEHICLES & TRAFFIC, SECTION 212-25

Section 212-25 of Chapter 212, Vehicles & Traffic, is hereby amended to add the following street locations to the list of stop intersections:

#### SECTION 5 – HOME RULE

Nothing in this Local Law is intended, or shall be construed (a) to limit the home rule authority of the Town under State Law to limit the Town's discretion in setting fees and charges in connection with any applications requiring Town approval.

### **SECTION 6 -- SEVERABILITY**

If any part or provision of this Local Law or the application thereof to any person or circumstance be adjudged invalid by any court of competent jurisdiction, such judgment shall be confined in its operation to the part of provision or application directly involved in the controversy in which judgment shall have been rendered and shall not affect or impair the validity of the remainder of this Local Law or the application thereof to other persons or circumstances, and the Town of Lewisboro hereby declares that it would have passed this Local Law or the remainder thereof had such invalid application or invalid provision been apparent.

#### SECTION 7 – EFFECTIVE DATE

This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Section 27 of the Municipal Home Rule Law.

### POLICE – Commercial Road Check

FINANCE - Bond Update (7:44 - 7:57 p.m.)

Supervisor Parsons started by congratulating our Town Comptroller, Leo Masterson, who has been working hard over the years to reduce the Town's borrowing costs. Mr. Masterson updated the Board on Town borrowing (see attached).

Mr. Masterson stated that we had eight bidders with the lowest one coming in at 1.77%. Treasury bond rates have been lower.

Supervisor Parsons asked the Comptroller if we should favor BANS for the 2020 budget to do paving work, purchase trucks, etc. or if they should include this in taxes. This will be looked at and discussed closer to budget time.

Mr. Welsh stated that he feels the Board should think about assembling a virtual capital purchasing plan to see what it would look like with the current low rates. Mr. Welsh also suggested the Board possibly go out to the public to see if they want to do an infrastructure bond.

The Board thanked Mr. Masterson again.

## <u>POLLINATOR PATHWAYS</u> – Discussion (7:58 – 8:04 p.m.)

Supervisor Parsons was asked by the Lewisboro Garden Club and the Lewisboro Land Trust to publicize about the need for pollinator pathways in our town. The pollinators include bees, moths, bats, beetles, flies, birds and butterflies that move pollen from one plant to another. They enable cross-fertilization of plants promoting reproduction and the growth of new plants.

Steps to becoming part of a pollinator pathway and creating pollinator habitats include planting diverse native plantings on your property or even a window box or container with pollinator plants. Avoid using pesticides and eliminate leaf blowers and overnight lighting which can disrupt pollinator activity. More information can be found at <a href="https://www.xerces.org">www.xerces.org</a>.

<u>HART TRANSIT</u> – Larger Busses (8:13 – 8:20 p.m.)

Mr. Welsh wanted to open up conversation about the HART (Housatonic Area Rapid Transit) bus, which is the shuttle bus to the Katonah train station. Supervisor Parsons stated that when the Town first signed up with HART, they were only running smaller busses. As the shuttle became more popular, they started using a few larger busses which now pull down Boutonville Road to Spring Street, to the Spring Street parking lot which is located across the street from St. John's Episcopal Church (the larger busses are too large to turn around in the parking lot with all of the cars). The smaller busses are still able to turn around in the parking lot so they enter at Spring Street.

Also, in the past, the pick-up location was only at the Spring Street parking lot, however, now they tend to pick up residents all along Route 35.

Mr. Welsh and Ms. Crimmins suggested putting a sign up at the Spring Street parking lot inviting permit holders and residents to come to the Town Board meeting on April 22, 2019 to voice their opinions of what is working, what is not working, etc. The Board also asked that this discussion be publicized in the paper.

<u>FEDERAL COMMUNICATIONS COMMISSION (FCC)</u> – Limits Local Control for Deployment of 5G Network

Supervisor Parsons stated that Federal Communication Commission's (FCC) deadline to adopt a policy for aesthetic considerations associated with the siting of small cell 5g facilities expires on April 15<sup>th</sup>. FCC decided to take away most of the municipalities' power to regulate 5G installations unless a resolution/law was in place. The Board passed the following resolution:

Highway Superintendent Peter Ripperger did discuss this on several occasions over the last few years with the Truesdale Lake Association. However, Supervisor Parsons stated that Mr. Ripperger did have to go out of town to take care of a family matter and did not make the lake residents aware that the replacement would take place today. Mr. Welsh stated that regardless, the aesthetics is not pleasing to the residents. He suggested that the guardrail be dressed up with a wooden box. Other Board members suggested painting the guardrail.

Supervisor Parsons did drive by the guardrail twice today. The Board will look at the guardrail and will discuss the situation with Superintendent Ripperger upon his return.
