A meeting of the Town Board of the Town of Lewisboro, Westchester County, New York, was held on April 22, 2019 at 7:30 p.m. at the at the Lewisboro Library, 15 Main Street, South Salem, New York.

Supervisor Parsons called the meeting to order at 7:32 p.m.

EMERGENCY PROCEDURE

Supervisor Parsons noted the exits to be used in the event of an emergency.

PLEDGE OF ALLEGIANCE

The Supervisor led the Pledge of Allegiance to the flag.

<u>PUBLIC HEARING</u> – To Enact Chapter 220, Section 220-43.6 entitled "Gasoline Service Station" (7:32 – 7:40 p.m.)

Supervisor Parsons called the public hearing to order. There was no objection to the time or form of the public notice (attached).

Andrea Rendo, a Vista resident, stated that while she does not see the need for a 7-Eleven or another gas station in the Cross River area, she questions the timing of this local law and feels that it seems a little suspect. She feels that it is directed toward a certain applicant. And is the Town opening themselves up to further litigation. Ms. Rendo feels the Board is putting the cart before the horse since she knows they are looking at an updated Master Plan. Ms. Rendo asked if zoning changes at this stage were somewhat piecemeal and perhaps may not make sense in the bigger picture of creating a new Master Plan.

Supervisor Parsons stated that the Town Board requested the Town Attorneys to draw up a draft of this law before any application was received and that the Board was assured by the Town Attorneys that if this law is passed before the application for the 7-Eleven is passed by the Zoning Board the Town Board is on safe ground.

Nancy Kozuchowski, a resident of the Meadows stated that they had already suffered through a gas leak from Shell several years ago and would not want to see this happen again. She is opposed to another gas station.

Town Attorney Anthony Molé did caution against making any comments related to anything other than the town wide restrictions that were the subject of the public hearing.

Lisa Miller, a resident of Mark Mead Road did state that she read the proposed law that was on the website and appreciated the law being passed.

With no other comments, Supervisor Parsons stated that he would hold the public hearing open until June 10th so that the Planning Board could submit their comments. He also invited any others to comment via letters or emails.

COMMUNICATIONS

RECYCLING - ECO Award

Supervisor Parsons stated that the Town received an ECO Award for recycling. The Sustainability Co-Chairs Robert Karpel and Elizabeth Meyer Gross attended the award ceremony today in White Plains. Supervisor Parsons also stated that the Katonah Lewisboro School District also won an award for the use of wind power. Mr. Walsh stated that Sustainable Westchester won an award for community solar.

EARTH DAY - Acknowledge

Mr. Welsh mentioned that today was Earth Day. He also pulled out of the archives the Climate Smart Community Pledge that the Town made in 2010 which lays out a very ambitious agenda for the Town. He feels that we have a long way to go and we should get back on track with our environmental goals.

PUBLIC COMMENT PERIOD

HIGHWAY – Leaf Removal

A resident asked if the Town offers any collection of leaves. Supervisor Parsons stated that the Town used to offer this in the lake areas only. He stated that a predecessor removed it from the budget because it was expensive and it was discriminatory since it was only offered in the lake communities. Supervisor Parsons suggested that if they really want this service they should attend the Town Board meetings around budget time and suggest this service at this time.

HART TRANSIT – Presentation and Discussion (7:55 – 8:24 p.m.)

Supervisor Parsons introduced Richard Schreiner, Service Development Director of Housatonic Area Regional Transit (HART) who was invited by the Board to discuss the HART shuttle bus that runs between Ridgefield, CT to the Katonah train station. This service started back in 2002 and is funded jointly by New York and Connecticut. Mr. Parsons stated that he considers this a very valuable service inside the town and the question is how can we further reduce the traffic on Route 35 by making greater use of the HART shuttle.

Supervisor Parsons did state that a group of supervisors were able to obtain a million dollar study to figure out the problem at the junction of 684 and 84 which is a DOT study. The funding has been approved however the study has not been implemented. They are waiting for the study to be completed and action taken could take a very long time. So the question is what can be done in the meantime to alleviate traffic on Route 35.

Mr. Schreiner stated that there are between 190 - 200 individual riders a day; the 20-passenger busses are usually at least half full and in the mornings there is at least one trip when a full-size bus and a van run back-to-back. There are two official stops in Ridgefield and one official stop in South Salem at the Spring Street parking lot next to the State Troopers house. However, Mr. Schreiner stated that there are flag stops along the way which is something that New York State DOT wanted them to do on all of their services in New York. The Board asked about the rate of

frequency of these stops and was told about 3 plus along the route daily. Mr. Schreiner stated that the Meadows is a large flag stop. He also stated that in the past they have asked the owner of the Orchard Square parking lot in Cross River if residents could park cars there however they denied them permission. The Board suggested that Mr. Schreiner approach them again.

One resident asked about the hours of the shuttle. Mr. Schreiner stated the shuttle arrives at Katonah in time for the 6:11 a.m. train with the last train of the morning being 8:16 a.m. She asked if the time could be lengthened to 10:00 a.m. when the senior citizen discounts apply for the train tickets and the answer was no, not until more funding is made available.

Town resident and Confidential Secretary/Benefits Coordinator Mary Hafter stated she feels that the HART shuttle is a great service and she and her husband are big proponents of this program. She stated that she does not feel enough people know about this program. Ms. Hafter also stated that she works and lives close to where the shuttle goes and she rarely sees a shuttle bus.

Supervisor Parsons would also like to see a shuttle go from Ridgefield through Vista to New Canaan or even to Stamford or Darien. Mr. Schreiner stated that survey data is needed to make the case to expand the shuttle service.

The Board will look at ways to market this service in order to increase the usage. The Board thanked Mr. Schreiner for his presentation.

HIGHWAY – Proposed Connecticut Tolls (8:26 – 8:29 p.m.)

Supervisor Parsons stated that Connecticut is looking to possibly install tolls on the Merritt and on Interstate 84 & 95. In doing so, Supervisor Parsons feels that many will then go on local roads where no tolls would be taken, making local traffic even worse. Supervisor Parsons will be attending a few meetings with the Ridgefield, CT Mayor, Rudy Marconi.

PACE OUTREACH PROPOSAL – Discussion (8:32 – 8:34p.m.)

Mr. Parsons stated that there have been revisions made to the Energy Improvement Corporation's (EIC) PACE Finance Services to make it more accessible to clean energy projects. The Town already has a local law for NY State's Pace law. The Town is not required to change the law, however, if the town does not change to conform to the new state guidelines, residents, businesses and the Receiver of Taxes are still subject to the old guidelines. A public hearing will be held.
