Approximately 22 residents/observers attended the live meeting and approximately 26 participated via Zoom.

Supervisor Gonçalves called the meeting to order at 7:35 p.m.

Supervisor Gonçalves noted the exits to be used in the event of an emergency.

The Supervisor led the Pledge of Allegiance to the flag.

## PUBLIC COMMENT PERIOD (7:40 – 8:05 p.m.)

A total of 11 residents spoke.

#### ISRAELI – HAMAS CONFLICT

Approximately 5 residents spoke out against Councilman Welsh and continued to criticize him for what they feel are antisemitic posts on his personal Facebook page. They stated that his behavior is not fitting of a Town Board member. These residents continue to feel that he is dividing this town when we need to be unified and continue to ask Councilman Welsh to resign. They feel he should not be in the rotation as a Deputy Supervisor. They also stated that in his capacity as a Town Board member he should not be posting about these issues on social media. If he wants to post on his personal page, they feel he should not list that he is a Town of Lewisboro Councilman. Another resident stated that Councilman Welsh represents the people of Lewisboro and is not a delegate to the middle east and what we do in Lewisboro won't fix the world problems. They continued by saying that the Board should focus on town issues and they represent many people.

Approximately 4 residents spoke out in favor of Councilman Welsh stating that they don't believe he is anti-Semitic but rather anti-war. They feel that Councilman Welsh's voice should not be shut down. They stated that his views are held by others as well in the community.

Another resident suggested that the board set up a professionally facilitated meeting that engages those who want a dialogue on this topic.

During polling of the Board, Board members addressed the audience. Councilman Sklarin stated that everyone is equally important, and the Board does the best that they can to hear all residents and he hopes that the presentation from this evening helped some to feel that they have been heard. Councilwoman Shah has worked her entire life to make sure that people feel safe and welcome, and she will continue to do so. Supervisor Gonçalves stated that none of us want violence in this world but it's an unfortunate characteristic. Supervisor also stated that they cannot remove Dan Welsh from his elected office.

#### HIGHWAY

A resident complimented the new Highway Superintendent John Winter and the highway department for removing the timber from the salt dome.

## **INTERNET SERVICE**

A resident stated that she has made the switch to Hughesnet and finally got rid of Verizon. She is very happy with it and urged more people to use Hughesnet or Starlink.

## GOLDENS BRIDGE FIRE DEPARTMENT

A resident thanked the Goldens Bridge Fire Department for battling brush fires and downed wires during school dismissal. Traffic needed to be rerouted and they kept all safe. She also shared the sudden passing of Chief Ray Baker Sr. who has been with the Goldens Bridge Fire Department since 2015.
